

Gem County Rod & Gun Club Meeting Minutes

September 9th, 2019

Directors Present: Larry Robertson, Caleb Hoobery, David Larson

Officers Present: President Russell Trebby, Secretary Jim Bunting, VP Greg Kershul

Meeting was called to order by President Trebby at 7:05 pm.

Motion was made by Director Caleb Hoobery to approve the August 2019 Board of Directors/Officers minutes. Minutes seconded by Director Larry Robertson and carries.

Point of information: VP Greg Kershul asks if the board made a plan to take inventory. President Trebby says an organized plan has not been made yet.

Member concerns and comments: Member Dennis Wiley who runs the 22 precision matches asks if he could run events on the range due to low usage of the gun range during this hunting season. Dennis states that the range is not seeing its high usage of people sighting in their rifles as it usually does. VP Greg Kershul states that there is low traffic now but he expects October to be busy. Dennis asks the board to review its reservation policy. VP Greg Kershul asks Dennis if he would like to serve on the Range Maintenance Committee board and Dennis will consider it.

Range report: VP Greg Kershul states the range is in reasonable condition. Rifle racks may need some work. VP Kershul will also go to the range Wednesday to check on the roofs of the covered range bays. Secretary Jim Bunting states that the wood pile by the rifle range connex has been taken to the dump.

Padlock on the gun range gate has gone south and has been replaced by President Trebby. Dennis Wiley says the current lock is having troubles too.

Range Maintenance Committee: VP Greg Kershul reports that of the last 15 years he has been around the club the board has maintained management of the range maintenance. Director Brad Newell was the range maintenance guy for many years. The bylaws of the club provide for committees of

directors to be formed for a specific purpose. The board can set up a committee for the purpose of range maintenance only. VP Greg Kershul wants to know if any directors/Officers will volunteer to serve on a range maintenance committee. Director David Larson said he would serve. The basic concept of the committee created by the BOD would be to take charge of the duties of maintenance on the range in an orderly fashion. Member Perry Saathoff said he would like to serve as well.

President Trebby would also like to see the new connex get dedicated to range maintenance only.

Motion: Caleb Hoobery make a motion to form a Range Maintenance Committee being chaired by Dave Larson to be formed in perpetuity and to adhere to the bylaws of the club with naming Greg Kershul as Secretary. Motion is seconded by Director Larry Robertson and it carries.
